

PERSONAL RELEASE FORM – Synergy Schools Solar Challenge



I, _____, parent/guardian of
_____ ("Child"):

1. irrevocably authorise and grant Synergy (including its successors and assigns) the right to:
 - a. Take audio and visual recordings and photographs of my Child in relation to the Synergy Schools Solar Challenge;
 - b. 2. release Synergy from any liability resulting from:
 - a. the blurring, distortion, alteration, optical illusion or use in composite form of my Child's Appearance, whether intentional or otherwise, that may occur or be produced as a result of the reproduction, communication or editing of the Recording; and
 - b. the Use of any personal, proprietary or other right that I or my Child may have in relation to the Recording,
3. acknowledge that Synergy owns and shall own all rights, title and interest in the Recording. I irrevocably and unconditionally assign to Synergy all rights, title and interest (including all present and future copyright and other intellectual property rights) in and to the Recording from the date of its creation,
4. acknowledge that Synergy may assign rights in the Recording to the Science Teachers Association of Western Australia for the purposes of publicity, advertising and promotion,
5. consent to Synergy doing any act in relation to the Recording that is permitted by this release, even if that act would, apart from this release, infringe my moral rights in the Recording,
6. waive any right that I may have to inspect and/or approve the Recording or the advertising or printed or electronic copy that may be used in connection with the Recording, or to control the Use of my Child's Appearance in the Recording, or the disclosure of the Recording,
7. warrant that I have full power to enter into this release and that the terms of this release do not in any way conflict with any commitment on my part or my Child's part.
